in order to pass the judgement he took account of the following:

The court process of the case is with legal grounds according Article 119, Paragraph 2 of the Trade Law.

There is a request by the manager of the new founded limited liability company with description "Tsvetelina" Ltd, with head office Varna town to register it at the Trade Register, kept at the Varna District Court.

With the application form for registration are provided the documents required by the law and after assessed by the court regarding their regularity, it was found out that the request is well-grounded: basic instrument of limited liability company, consisting the requisites of Article 115 of the Trade Law, proof of deposited funds to the amount of 3 500 lv, representing 70% of the announced funds in an account of the new founded enterprise, notary certified agreement with a form with sample of the signature of the representative of the enterprise according Article 141, Paragraph 3 of the Trade Law, money order for the transfer of the governmental fee, certificate of the unique form of the name of the enterprise. The activities of the enterprise is trade according Article 1 of the Trade Law.

Having in mind the above described and based on Article 3, Article 119, Paragraph 2 and Article 141, Paragraph 3 of the Trade Law and following Chapter 52 of the Citizen Process Code, the District Court Varna

financial – management schemes, management and participation in the management of associations and funds including via acquisition, management, assessment and sell of patents and licence; distribution, internal and external trade; import and export of materials, raw materials, machines and services; transport and logistic services in the country and abroad, internal economical activity, specific external trade operations as well as any other activity and providing any other service unfobidden by law.

Sole owner of the funds is TSVETELINA GEORGIEVA GEORGIEVA, ID UCN 7706074570, Plovdiv, 19 Treti Mart Street, Entrance B /C/, floor 5

The fund of the enterprise is to the amount of 5 000 lv, deposited amount 70% of he capital at an account of the new founded enterprise.

The funds are divided into 100 shares of 50 leva.

The enterprise is founded for unlimited term.

The enterprise is managed and represented by the sole owner TSVETELINA GEORGIEVA GEORGIEVA with the above described identification data.
